# B. Proposed Decision:

CHRISTOPHER HERMAN, Park Ranger I filed 12/02/22 for a service connected disability retirement. Consideration under Government Code Section 31724 (date allowance becomes effective) and 31725.65 (reemployment plan) is requested. On 06/22/23, the Retirement Board denied the application for a service connected disability retirement.

Motion was made by Trustee Tambe and seconded by Trustee Baker pursuant to Government Code section 31534 to recommend adopting the Administrative Law Judge's proposed decision and grant Mr. Herman a service connected disability application. Government Code Section 31725.65 was reviewed and the recommendation is to grant the reemployment plan request.

Government Code Section 31724 was reviewed and the recommendation is to deny the request as there was no administrative oversight or inability to ascertain the permanency of the member's incapacity.

#### III. EXECUTIVE SESSION REPORT OUT – OPEN SESSION

Committee Chair Brian Williams reported out in open session that the Committee voted unanimously to recommend granting a service connected disability retirement to Sergeant James Percy and a non-service connected disability retirement to Animal Control Officer Justin Foster. A motion to recommend granting Deputy Sheriff II Michael Dietrick a service connected disability retirement failed for a lack of a second. The Committee voted 3-1-0-1 to recommend denying Deputy Sheriff II Michael Dietrick a service connected disability retirement. The Committee voted unanimously to recommend adopting the Hearing Officer's Proposed Decision to grant Park Ranger I Christopher Herman a service connected disability retirement. The Committee unanimously voted to recommend granting his request for Government Code Section 31725.65 and to deny his request for Government Code Section 31724.
