B. Retirement Board Resolution #156 – COVID State of Emergency and imminent threat of risk and Brown Act teleconferencing requirements discussion

Assistant Chief Executive Officer Cristina Hess presented a summary of the Brown Act legislation recently enacted that allows for teleconference participation by a Board Member in the event of an emergency or for just cause without strict adherence to the agenda posting and accessibility requirements. The legislation will apply after the Governor lifts the current state of emergency. Trustees asked for clarification on the number of times this teleconference legislation could be used in a year. Trustees discussed the need for continued use of the teleconference statute currently in place.

Chief Executive Officer Julie Wyne and Finance and Retiree Services Manager Cheryl Enold presented the 2023 Budget, noting that the main differences from last year's budget were disability retirement applicant medical reviews, which are very difficult to predict, several maintenance projects for the building and surrounding grounds and a software change for delivering Board materials to Trustees.

D. 2023 Committee Assignment Discussion

Ms. Wyne indicated that at the end of each year the Board Chair and the CEO compile the list of Committee assignments for the coming year and that this was an opportunity for Trustees to change their assigned committees. Trustee Tuscany, the 8th member, indicated he no longer wanted to serve on the Disability Committee which raised the issue of Trustee Baker, as the 8th alternate member, remaining on the Committee in the absence of the 8th member. Ms. Wyne indicated that it has been SCERA's position that the 8th alternate member act as a true alternate and not occupy a position on a Committee in the absence of the 8th member. Ms. Wyne indicated that there may be governance changes necessary for the expansion of this position but that ultimately it was the Board's decision to define the scope of the 8th alternate member's participation on the Board. Trustees indicated their support for Trustee Baker remaining on the Disability Committee due to his unique knowledge and history with SCERA.

E. COLA Discussion

Ms. Wyne provided a historical summary of the COLA program and the various statutory and policy changes that have occurred since the fist statutes were adopted in the 1960's. She noted that in the early 2000's SCERA changed its Actuarial Funding Policy in response to some significant investment market disruptions and changed philosophy in the actuarial community regarding the existence of true "excess earnings", and a tracking mechanism for interest crediting shortfalls was developed without a meaningful discussion of the impact on the COLA program. She indicated that the goal of this discussion was to provide direction to the four Trustees and her, as those designated to discuss the COLA program with County leadership. Trustees concurred that the ad hoc group would be meet and discuss the COLA history and other aspects of the COLA program and SCERA's reserve structure with the goal of identifying the information to share with the County to create a collective understanding of past actions, engage with County representatives to produce a decision by the County regarding future retiree COLAs and determine next steps after the County's policy decision.

F. Audit Committee Recommendations

Trustees inquired about whether cybersecurity was included in the audit and Ms. Wyne indicated that this auditor is focused on financial transactions and Ms. Enold indicated that they look at internal controls regarding information technology. Ms. Wyne further indicated that cybersecurity is a separate type of audit and that staff is looking at various service providers to provide this type of service in addition to the testing that is performed

in house.
