II. REGULAR CALENDAR

A. Discuss Retirement Board Resolution #156 – COVID State of Emergency and imminent threat of risk

Trustees discussed the uncertainty that still prevails with meeting in person, masking recommendations from the County Health Officer and CDC and the ability for those Board members who felt comfortable to attend meetings in person. Staff indicated that many of the other county retirement systems were still operating in a hybrid manner like SCERA under the state of emergency exceptions to the Brown Act and although the CEO prefers we get back to in person meetings and interactions, safety concerns are valid and understood. Trustees expressed a desire to maintain the status quo for now, with the understanding that once the state of emergency has been lifted they will be required to appear in person or comply with Brown Act teleconference provisions.

1. CALAPRS Advanced Principles of Pension Governance for Trustees, March 30 to April 1, 2022, Los Angeles, CA. Trustee Williamson reported all nine attendees, consisting of eight trustees and one staff person, at the first in-person CALAPRS Trustee training since the onset of the pandemic, were happy to learn and mingle together. He found it interesting to hear that several Retirement Boards from other systems delegate staff to hire and fire investment managers in lieu of the Investment Committee making the final decisions. After an economic update from Dr. Jerry Nickelsburg, the participants spent a considerable amount of time on governance and fiduciary principals centered on acting in the plan participants' best

interests. Investment and actuarial topics rounded out the sessions for an overall excellent program.

Mr. Balzarini attended, "Economic Perspective – Climate & Sustainability" presented by the Sonoma County Economic Development Board on April 2, 2022. Mr. Balzarini stated that the keynote speaker, Dr. David Roland-Holst, a UC Berkeley professor in the Agricultural and Resources Economics Department, provided an economic forecast as it relates to climate change impacts on our local economy. Dr. Roland-Holst and the other panelists also spoke about the reality of climate change and how quickly it was occurring, along with information about accessing investments in solar and wind power.
