Chair Williams reported the Board unanimously granted the service connected disability retirement applications of John Gillette, Deputy Sheriff II, Patrick Gillette, Deputy Sheriff II, and Julie Wolter (aka Tabsharani), Juvenile Correctional Counselor III.

IV. REGULAR CALENDAR

A. Educational Session – Good Governance and Disability Retirement

Assistant CEO/Chief Legal Counsel Cristina Hess provided an informational session that focused on the laws that govern SCERA, noting that the CERL, PEPRA and the Internal Revenue Code provide the structure that allows SCERA to function. Ms. Hess stressed that the purpose of the CERL and PEPRA are to provide retirement benefits to our members and focused on the different forms of disability retirement available to our members, should they qualify. She further noted that providing benefits that aren't authorized jeopardizes the plan's tax qualified status and puts SCERA and the Trustees (as individuals) at risk for lawsuits for breach of fiduciary duty. She reminded that actions by Trustees or staff that favor one group of members over another group could be a violation of fiduciary duties. She summarized that the Board has adopted strong governance polices and properly delegated the day-to-day operations to the CEO and her staff.

B. SACRS Board of Directors Election

Recommendation: Provide voting direction to the SACRS Delegate on the Board of Directors slate.
